REGISTRATION PROCEDURE

1. This registration application must be completed and received before the final registration date. In order to receive further updates and information, make sure all information is printed and legible.

2. Registration deadline in March 25, 2009. Early Bird Registration until March 14, 2009. The fee per adult team (age 19 & older and King of the Court Division) is \$85, (\$75 until March 14, 2009). The fee for the youth division (age 18 & under) is \$70, (\$60 until March 14, 2009). Your entry fee includes a tournament T-shirt. A team consists of four players. No registration will be accepted after March 25, 2009. Make checks payable to Jackson Rotary Club and mail to P.O. Box 414, Jackson, MO 63755, or fax to 573-243-1531.

3. False information is grounds for disqualification. Tournament Officials have the right to spot check player information. Proof of age is required upon request (photocopies accepted).

4. Each school district has different rules regarding eligibility of its athletes in off-season events. Each athlete should contact his/her athletic director to inquire about local rules of eligibility.

5. Each captain will receive confirmation by phone of receipt of his/her team's registration. Starting times and additional information will be given prior to the event.

7. Entry fees are nonrefundable and must be paid prior to event date.

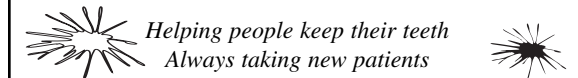

Cash prizes or trophies will be awarded in each age division.

Cash prizes per team are: 19-30+: 1st \$200, 2nd \$120, 3rd \$80. **King of the Court** (minimum of 10 teams for the King of the Court Division) prizes are: 1st \$500, 2nd \$120, and 3rd \$80.

Trophies will be awarded to all team members on 1st and 2nd place teams in all 18 & under divisions.
